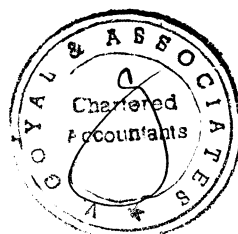

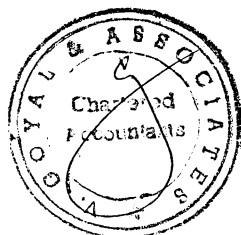
NOTES
